

Proposed Vulnerable Populations (VP) Categories

Source of Categories: Public Health Seattle and King County

rev. 10/12/007

Physically Disabled: full-time attendant care required for activities of daily living and/or instrumental activities of daily living

Data Definition: Population age 5+ with conditions that substantially limit 1+ basic physical activies such as walking, climbing stairs, reaching, lifting, or carrying **Blind*:** range includes: low vision, night blindness, color blindness, impaired depth perception, etc.

Data Definition: population living in the "Western" US report vision loss: trouble seeing, even when wearing glasses or contact lenses; blind or unable to see at all

Deaf, Deaf-Blind, Hard of Hearing*: latent deaf, situational loss of hearing, limited-range hearing

Data Definition: US adults age 18+ report experiencing some hearing difficulty without a hearing aid ("a little trouble, moderate trouble, a lot of trouble, deaf" **Seniors:** frail elderly, people who have age-related limitations/needs, includes those in nursing home or assisted-living care or living alone and not connected socially or to service providers

Data Definition: persons age 65 and older or 85 and older; population in skilled nursing^

Limited English or Non-English Proficient: includes persons with limited ability to speak, read, write or fully understand English

Data Definition: Population age 5+ speaking language other than English at home and speaking English less than "very well"

Children: anyone below age of majority separated from parents/guardians—child care, Head Start, before/after-school programs, latch-key kids, those in school, foster care, truancy, juvenile justice system

Data Definition: persons age 0-17; potential latch-key kids have single parent who is employed or two parent household where both parents are employed *Homeless and Shelter Dependent:* includes persons in shelters, on the streets or temporarily housed—transitional, safe houses for women and minors

Data Definition: Homeless: persons participating in the annual Point in Time Count. Public school students reporting homelessness at least once in the school year.

Impoverished: person with extremely low income, without resources or political voice, limited access to services, limited ability to address own needs

Data Definition: persons living in households with past 12 month income below 100% of the Federal Poverty Guidelines

Immigrant Communities: persons who may have difficulty accessing information or services because of cultural differences

Data Definition: persons reporting being born in a foreign country and having arrived in the US in 2000 or more recently

Undocumented Persons: persons distrusting authorities, political dissidents and others who will not use government or other traditional service providers

Data Definition: no known data source

Mentally III: serious and persistent illness; includes being a danger to themselves or others;

Data Definition: US population suffering from serious mental illness

Developmentally Disabled*: unable to safely survive independently, attend to personal care, etc.

Data Definition: US population with severe, chronic disability attributable to mental/physical impairments, manifested before age 22, continues indefinitely, results in limitations

Medically Dependent, Medically Compromised: dependent on medications to sustain life or control conditions for quality of life—i.e., diabetic; weakened

immune systems, those who cannot be in/use public accommodations

Data Definition: Adults age 18+ with at least one of the following chronic conditions: asthma, diabetes, myocardial infarction, angina

Chemically Dependent: includes substance abusers, others who would experience withdrawal, sickness or other symptoms due to lack of access

—i.e., methadone users

Data Definition: Adults below 200% poverty needing substance abuse treatment^

Clients of Criminal Justice System: ex-convicts, parolees, people under house arrest, registered sex offenders

Data Definition: Persons on supervision (community custody)

Emerging or Transient Special Needs: needs/conditions due to emergency, temporary conditions - i.e., loss of glasses, broken leg, tourists/visitors needing care

Data Definition: no known data source
